

As we near the end of the fifth week, we are also drawing nearer to the first legislative cutoff; at that point all policy bills must pass out their policy committees by 2/17 or they will die for the session. We are now at over 1,800 bills introduced so far this session, meaning the policy cutoff will reduce the number of viable bills for the session.

The cutoff following policy cutoff will be for fiscal committees to pass fiscal bills unless they are necessary to implement the budget.

***Nationstar hearings***

This week we helped introduce two bills that are largely placeholders for our negotiations around the *Nationstar* issue (HB 2057 / SB 5797). Both bills have been scheduled for public hearing on 2/14, and the WMBA will testify in support of the proposals. While the substance of the proposal continues to be negotiated, significant progress was made on the proposal this week, and we expect to see substitute bill language before the hearings next week. The House bill will be heard in the Judiciary committee, and the Senate bill will be heard in the Financial Institutions & Insurance Committee.

***Taxes on the table as House Democrats look at funding basic education proposal***

Now that the Senate has passed its education plan, the focus has now moved to the House. The House Democrats have also put forth their proposal to address the *McCleary* obligation, but it has not been passed out of the House yet.

In comparison to the major components of the Senate proposal, here are the major components of the House proposal:

- While the package indicates a need of roughly \$1.6 billion in new revenue over the next biennium, the exact revenue stream has not yet been identified. Potential sources identified include a carbon tax, capital gains tax, tax preferences, property tax adjustments, or changing the state’s B&O tax system.
- Teacher compensation for beginning teacher salaries would be increased to \$45,500, and a minimum of \$50,500 for teachers with three years’ work experience. Additionally, the plan requires an average salary of \$70,824 per teacher by the 2019-20 school year.
- Administrator pay would be increased to \$117,159.
- All salaries would also receive cost-of-living increases based on inflation, which would be adjusted every 6 years.
- Impose limitations on teacher unions’ right to bargain over local contracts with school districts.
- Would suspend parts of I-1351 for two more years, but fund certain portions, such as lower class sizes for career-and-technical education classes, or skills centers.
- The package does not require voter approval.

The House Appropriations Committee held a hearing on both the Senate bill (SB 5607) and the House bill (HB 1843) this week. The committee passed HB 1843 on 2/9.
