

3/8 marked the house of origin cutoff, where all bills must have moved out of their house of origins to remain alive, unless they are necessary to implement the budget.

The next revenue forecast is next week on 3/16, and the first budget proposals are anticipated to be released a few days later. The Senate will release its proposal first, with the House following a few days after.

Nationstar negotiations continue

We have continued to meet with stakeholders in an effort to address the recent decision in *Jordan v. Nationstar*. We have two bills (HB 2057 / SB 5797) which we continue to push forward as the negotiations continue. We have a public hearing on the House bill in the Senate Financial Institutions & Insurance Committee on 3/14, and another stakeholder meeting on 3/15.

Senate passes levy cliff bill

As the last bill to make it out of the Senate before the 5:00 p.m. cutoff deadline, the Senate passed a proposal (SB 5023) to extend school districts' current taxing authority for another year in order to address the so called "levy cliff." School districts have been arguing for two years that they needed this extension to avoid losing between \$350 and \$500 million in the 2017-18 as the districts' ability to raise property taxes locally is reduced beginning in January, 2018. The bill as it passed the Senate would allow current levels through January, 2019, and also requires that districts ensure the local levy spending is on non-basic education costs.

Democrats have been pushing hard to bring the proposal up for a vote, particularly as the House passed the measure earlier this session. Republicans had been pushing against the need for the proposal this year, arguing that it would ultimately be addressed in the final *McCleary* package, and would also take pressure off members to come to a resolution on the larger *McCleary* solution. The bill passed with a vote of 47 to 1, and now goes to the House for consideration.

Senate debates issues around taxes

The Senate Republicans attempted to bring two proposals to the floor on 3/7 with opposite points around the state's taxation policy:

- The first proposal (Senate Joint Resolution 8204) would amend the state Constitution to prohibit an individual income tax. Constitutional amendments require a 2/3 vote, and the bill failed with a vote of 27 to 22. Two Democrats voted with the Republicans, Senators Mullet and Hobbs.
- Conversely, SB 5111 is the Governor's proposal to impose a 7.9 percent capital gains tax. The Senate Republicans tried to bring the bill to the floor for a vote; however because of a 2/3 procedural rule that the Senate imposed on itself earlier this year for all tax increases, the bill failed to receive the required 2/3 vote, so was held on the second reading calendar.

Bill prohibiting contributions to the governor from entities engaged in collective bargaining passes Senate

A proposal that would prohibit entities that engage in collective bargaining with the Governor from making contributions to the Governor's election (SB 5533) passed the Senate on a strict party line vote on 3/7. The bill, sponsored by Sen. Rossi (R, 45th LD), would also prohibit any political committee from making an independent expenditure for or against any Gubernatorial candidate, and provides for a referendum to be submitted to voters at the next general election. The bill now moves to the House for consideration.
