

We have now wrapped up week six, and the first official cutoff of the session. At this point, all policy bills must have passed out of the policy committees by Friday, 2/17, or they are dead for the session. Nearly 2,000 bills have been introduced to date, and expectations are that many will die during the cutoff process. The fiscal cutoff—where fiscal bills must pass out of the fiscal committees unless they are necessary to implement the budget—is on 2/24.

***Jordan hearings***

There were two hearings last week to move the bills forward and keep the *Jordan v. Nationstar* fix moving forward past the cutoff. HB 2057 and SB 5797 both had public hearings, and were passed out of the committee. The bills have not yet been perfected, and negotiations have continued. The next stakeholder meeting is on 2/21.

***Another Senate Democrat proposal on K-12 funding released***

A moderate group of Senate Democrats—including Senators Mullet, Hobbs, and Takko—released a new package ([SB 5825](#)) to fund education last week. Among other things, the package:

- Imposes a local regular levy which may only be used for education purposes, and a hold harmless provision to offset any funding reduction to a school district;
- Repurposes local maintenance and operations levies as “enrichment” levies which can be levied at a maximum of \$1000 per pupil;
- Reforms state levy equalization;
- Revises compensation for certificated instructional staff by replacing minimum salary requirements for new teachers with a minimum requirement of \$45,000 and specifies that additional salaries for non-basic education services must be done through separate contracts; and
- Sets up a hybrid per pupil funding model for general education expenditures while retaining the prototypical model. The proposal includes a minimum total per pupil allocation of \$11,500.

Additionally, a group of 13 democrats proposed a constitutional amendment to allow a simple majority voter threshold when authorizing school district bonds ([SB 8202](#)). A constitutional amendment would be on the November ballot for consideration by voters.

***Revenue update***

The Economic & Revenue Forecast Council released its February [economic and revenue update](#) on 2/13. In the update, the state general fund-state collections were \$27.1 million (1.7%) higher than the November forecast. Cumulative, collections are now \$110.5 million (2.2%) higher than forecasted. Some of the shifts were due to large one-time payments as well as a delay in an expected refund. Netting these out, cumulative collections are still \$93.4 million (1.9%) higher than forecasted.

Overall, Washington’s housing construction finished the year strong, and employment has been stronger than the November forecast. Seattle home prices continue to rise rapidly, and consumer price inflation remains well above the national average. Exports have slowed in the fourth quarter of 2016.
