

This week marks the fourth week of the legislative session. Hearing schedules continue to be full of public hearings and work session, but we expect to move towards more executive actions in the next couple of weeks as we near the first cutoff of the session for policy bills. All policy bills must pass out of their policy committees by 2/17 in order to remain alive for the session.

#### ***Retirement marketplace bill being heard***

The bill making technical adjustments to the small business retirement marketplace program (SB 5675) has been scheduled for a hearing in the Senate Financial Institutions & Insurance Committee on 2/7. The business community does not have any concerns with the changes being proposed to the statute.

#### ***Rep. Short moves to the Senate***

Former Rep. Shelly Short (R, 7<sup>th</sup> LD) has now moved to the Senate after the departure of former Senator Brian Dansel left to work for the Trump administration. Senator Short will now be the chair of the Local Government Committee, and will sit on the Agriculture, Water, Trade & Economic Development, and Energy, Environment & Telecommunications Committees.

Meanwhile, Short's past legislative assistant, Jacquelin Maycumber (R), has been sworn in to replace the House seat. And Rep. Shea was voted in as caucus chair, replacing Short's leadership position.

#### ***Eyman eyes another initiative***

Tim Eyman is shopping his latest initiative, which he is deeming the Property Tax Fairness Initiative ([I-1550](#)). Under the proposal:

- Property taxes would be reduced by 25% across-the-board (not including voter-approved levies such as school levies).
- Property tax increases would be capped at 1% per year unless voters approve a larger increase.
- Eliminates the personal property tax.

#### ***Republican education plan passes the Senate***

The Senate republicans released their education funding package on 1/27, and passed the measure off the floor on 2/1 with a partisan vote. As a reminder, the proposal would address the final components of the *McCleary* obligation through:

- Elimination of the prototypical school funding model and move to a per pupil allocation funding model (setting the floor at \$12,500 per student);
- Allowing local governments to authorize local levies for non-basic education costs;
- Removing the teacher salary allocation scheduled, and set a minimum salary of \$45,000 and providing additional salary for factors such as cost-of-living, or advanced degrees;
- Providing top teacher grants and the ability to terminate non-performing teachers;
- Including a referendum for the entire act except for a delay to the levy cliff.

The Democrats offered six floor amendments, all of which failed.

#### ***Non-compete agreements***

Rep Stanford introduced his non-compete bill late this week (HB 1967). While the proposal showed up on the introduction sheets, the bill language is not yet available online. Rep Stanford is the only sponsor on the bill.

#### ***Competing family leave proposals introduced***

The House Democrats' proposal for paid family leave (HB 1116) that would allow employees to take up to a total of 38 weeks of paid leave per year once fully implemented and is funded through a payroll tax paid by both employees and employers has been scheduled for a public hearing in the Appropriations Committee on 2/9.

The Senate companion (SH 5032) had a public hearing in the Senate Committee on Commerce, Labor & Sports on 1/30. During the same hearing, a separate proposal (SB 5149) with bipartisan sponsorship will was also heard. This proposal would allow for up to 12 weeks of paid leave upon full implementation. The funding mechanism for the Senate bill would come from a payroll tax paid by employees. Neither of the senate bills have been scheduled for executive action.
