

We now have roughly five weeks left in the 2017 regular session. The next cutoff for policy bills to pass out of committee is on March 29. After that date, the fiscal cutoff will occur a few days later, where fiscal bills must pass out of the fiscal committees by April 4, unless they are necessary to implement the budget.

***Nationstar negotiations continue***

We have continued to meet with stakeholders in an effort to address the recent decision in *Jordan v. Nationstar*. The House bill (HB 2057) had a public hearing and executive action in the Senate Financial Institutions & Insurance Committee on 3/14. We held stakeholder meetings on 3/15 and 3/17. The Senate bill (SB 5797) is scheduled for a public hearing in the House Judiciary Committee on 3/21. We are very near to finalizing the last draft for consideration by our membership.

***Quarterly revenue forecast up \$737 million***

The Economic & Revenue Forecast Council released its updated [quarterly revenue forecast](#) today (3/16). The revenue forecast was adjusted up by the following amounts:

- \$247 million GF-S in 2015-17
- \$303 million GF-S in 2017-19
- \$197 million GF-S in 2019-21

Generally, the Council reported that Washington’s economy continues to be strong, with risks to the baseline due to slow global and federal growth, and weak labor productivity growth and uncertainty around fiscal and trade policies.

***Governor signs levy cliff into law***

On 3/15, Governor Inslee signed into law a bill that maintains the local school district levy lid at 28% until 2019. Under the current statute, beginning in 2018, the lid would have dropped to 24%, which was estimated to reduce local revenues by an estimated \$350 to \$500 million in the 2017-18 school year. This new law will continue to allow most school districts to raise up to 28% of their operating revenue through voter-approved property tax levies for this duration. Meanwhile, the Legislature will now continue its work on the larger issue of addressing the *McCleary* decision this session.
